NELSON COUNTY KY TAX SALE PROCEDURES

- Our tax sale will be held on Thursday, July 20, 2023 beginning at 9:00 AM.
- Sale registration form, registration fee, purchase list, priority list & deposit is due by Monday, July 10, 2023.
- Registration fee is \$10.00 for each bill on the purchase list, \$5.00 for each bill on the priority list with a maximum fee of \$250.00. This fee is <u>nonrefundable</u>. The Registration fee needs to be a separate check from the deposit check. All fees must be paid with a Cashier's Check or cash only (no personal or business checks will be accepted).
- Priority list must include the following: current year tax bill number, name on the tax bill, amount due on the certificate of delinquency, prior year certificate of delinquency bill number & prior year certificate of delinquency tax year. We will also need an electronic copy of this list (excel format).
 Please note the electronic copy only requires Map number, Bill number, Tax year & Property address in that order. Use excel 2003 format if possible. See example on page 3.
- Purchase list <u>must</u> be in priority order. This will be an electronic sale this year so only include the bills you wish to purchase. We will also need an electronic copy of this list (excel format). Please only include the same information as what is needed for the priority list electronic list. See attached copy for an example.
- The sale registration form is available online at <u>www.revenue.ky.gov</u> or you can contact us and we will fax you a copy. The deposit amount will be 25% and will need to be included. We can only accept cashier's checks. Please also include a copy of your registration certificate issued by the Department of Revenue.
- A lien fee in the amount of \$30.00 for each tax bill you wish to purchase must also be included with your registration packet. We can only accept cashier's checks.

- Remember, any one company or individual, planning to buy more than 3 certificates of delinquency in our county, more than 5 certificates of delinquency statewide, or invest more than \$10,000 dollars statewide in the calendar year <u>must</u> be registered with the state before they can participate in our sale.

- 7. Please submit a separate list of the current year certificates of delinquency for which no prior year claim exists you would like to purchase at the tax sale. This list must be submitted at least 10 days prior to the tax sale. For each certificate of delinquency the following information needs to be provided:
 - 1. Tax bill number;
 - 2. Taxpayer name;
 - 3. Amount due on the certificate of delinquency;
 - 4. County account/parcel number (if applicable); and
 - 5. The total due for all certificates of delinquency.

Your deposit must be received no later than five days prior to the tax sale date. Acceptable forms of payment include: Cashier's Check or cash.

- 9. Registration fee: Total number of certificates listed in Item 6 times \$5.00 plus the number of certificates listed in Item 7 times \$10 00. The maximum registration fee is \$250.00. Please include a separate payment for this amount with your registration.
- 10. Please read and confirm the following sworn statement. Be advised that filing a false sworn statement with the intent to mislead a County Clerk is a violation of KRS 523.030 and is a Class A Misdemeanor.
